DATES TO REMEMBER IN 2012



Jan. 15–Feb. 15—Application period for wild turkey and spring black bear controlled hunts.
April 1-30—Application period for mountain goat, bighorn sheep and moose controlled hunts.
May 1-June 5 —Application period for deer, elk, pronghorn, fall black bear and fall turkey controlled hunts.
December 1—Nonresident 2013 licenses and general season tags available.

Purchase Methods

Beginning December 1, nonresident licenses, general season tags and permits may be purchased at Fish and Game offices, over the phone, on the internet or at any of more than 350 license vendors statewide. There is a quota on deer and elk tags, so don't delay that purchase. You may have a relative or friend purchase for you at a vendor if they have the identification information requested on the front of this form.

You may add a tag for another species via credit card purchase, over the Internet or at a license vendor. If you buy an elk tag in December, and decide in March to add a deer tag, you can do it!

Credit Card Purchase: Visa, MasterCard and Discover. Dial **1-800-55HUNT5 (554-8685)** beginning December 1. You can also make your purchase online at <http://fishandgame.idaho.gov>. There is an extra charge for this service. The advantage is immediate confirmation of purchase, with no uncertainty about missing the quota.

Mail: Fill out and mail in this form, along with proper payment, to the address on the front of this application. Processing of applications received in the mail begins December 1. Be sure the correct amount is submitted in check or money order. If more than one application is mailed per envelope, but only one check to cover them all, be sure the amount is correct. An error could result in delay or return of all the applications in the package. Personal checks accepted.

There is a quota on nonresident deer and elk tags. Purchasing early is the best way to ensure that you get them. Any nonresident deer or elk general season tags remaining unsold after August 27 may be purchased for use as a second tag. If you use an outfitter, the outfitter must purchase your tags.

Other Important Information

Idaho Hunt Planner: Plan your hunt with the Idaho Hunt Planner at <http://fishandgame.idaho.gov/ifwis/huntplanner>. The Idaho Hunt Planner includes detailed maps and can answer many questions hunters have about Idaho's hunting rules, dates, special hunts and species with links to outfitters, accommodations and other needs. You can also access harvest information and controlled hunt drawing odds for big game species through the Hunt Planner.

Licenses, tags and permits are not transferrable. Refunds are allowed as specified in the big game rules.

Migratory Bird License Validation: Required to hunt any species managed by the U.S. Fish and Wildlife Service as a migratory species. Collection of data under the Migratory Harvest Information Program will provide a better basis for management of interstate/international species.

WMA Upland Game Permit: Pheasants are stocked on several Wildlife Management Areas owned by the Department of Fish and Game. The \$51.75 permit is only required when hunting pheasants on Market Lake, Mud Lake, Sterling, Fort Boise, C.J. Strike, Montour, Niagara Springs, Payette River and Cartier Slough WMAs.

Deer Tags

Idaho has two general season deer tags, regular and white-tailed. A nonresident deer tag may be used to take black bear or mountain lion where a deer season and bear/lion season are both open. The tag cannot be used for deer after it is used to tag a bear or mountain lion. All tags are available on a first-come, first-served basis on December 1 at midnight.

White-Tailed Deer Tag: The white-tailed deer tag is valid only in units specified for that tag. The white-tailed deer tag can be used to harvest a white-tailed deer only and allows hunting opportunities in September, October, and November hunts. If you plan on hunting during the later November white-tailed deer rut hunts, the white-tailed deer tag is the right tag.

Regular Deer Tags: The regular deer tag is valid only in units specified for that tag. The regular deer tag usually can be used to harvest either white-tailed or mule deer and is valid for any general hunt PRIOR to November 3. If you plan to hunt during September or October, and prefer to hunt both white-tailed and mule deer, a regular deer tag is the tag you will want to purchase.

Elk Tags

For general season elk hunting the state is divided into 29 zones. See Big Game Rules for tag types. Nonresident Selway B elk tags go on sale at 10 a.m. Mountain time on December 1. All other nonresident tags go on sale December 1 at midnight.

You may exchange your elk tag for one in another zone until the opening of the first season for which your tag is valid. Cost is \$3.75. If you have purchased a tag, you may apply for a controlled hunt in any zone and if you are drawn your tag will be exchanged for the proper controlled hunt tag. Elk tags will likely be sold out before September.

Archery Hunters

Idaho requires all first-time bowhunters to pass an archery education course. Experienced hunters are exempted. Please fill in the archery information at the top of front page of this application, or complete the affidavit at the bottom of this page.

Please buy early!

Nonresident deer and elk tags are limited and typically sell out before the season begins.

The Idaho Outfitters and Guides Board website at www.state.id.us/oglb/oglbhome.htm includes a search engine that will help you locate outfitters by activity and by area; for a list call 208-327-7380. Use of an outfitter or guide is NOT required by law.
